

BYLAWS COMMITTEE TIMELINE – PER BYLAWS

(The following dates are proposed for the Southern California Conference 66th Constituency Session in compliance with the current Bylaws)

- September 2021** Bylaws Committee organized
 (“No later than three (3) years following the session during which this committee was elected, the president shall call committee members together for the initial meeting of this committee. The president shall preside over the initial meeting of the committee solely for the purpose of overseeing the committee’s election of its chair and a committee secretary.”) BL 8.1
- June 30, 2024** Bylaws Committee asks delegates to submit their proposals for changes
 (“The bylaws committee shall announce at least twelve (12) weeks prior to a regular session a time and place for submitting written proposals for and consideration for amendments.”) BL 8.1.2
 (“Such announcement shall be by written notice to (i) the pastors, (ii) delegates, and (iii) the first elders. A church may submit proposed amendments to the bylaws that have been approved by either a majority of its (i) delegates, (ii) church board, or (iii) the church in business meeting.”) BL 8.1.2
- July 21, 2024** Bylaws Committee receives written proposals for Bylaws Amendments.
Bylaws Committee will meet June 23 to consider these Bylaws
 (“All proposals regardless of method of delivery must be received by the bylaws committee chair or Conference executive secretary at least one (1) week prior to the meeting of the committee where such proposal shall be presented. The proposal shall include indicated changes with a justification for such proposal.”) BL 8.1.2
- July 28, 2024** Bylaws Committee submits its report to the Executive Committee
 (“The bylaws committee shall submit its report to the executive committee not later than eight (8) weeks prior to the session.”) BL 3.3.2
- July 28, 2024** Conference Secretary distributes the Bylaws Report to all delegates
 (“The secretary shall include any proposed amendments in the session report.”) BL 3.3.2
 (“The secretary shall publish a session report...which shall include... bylaws, and other reports required by these bylaws ...The report shall be sent six (6) weeks prior to the session.”) BL 3.3.3
- September 29, 2024** Bylaws Committee reports at the SCC 66th Constituency Session
 (“The bylaws committee shall submit a report to the delegates at the regular sessions.”) BL 8.1.1
